THE AUDIT COMMITTEE HAS RESPONSIBILITY FOR RECOMMENDING THE SELECTION OF THE AUDIT FIRM. IF THEY RECOMMEND A CHANGE, THEY WOULD PARTICIPATE IN DEVELOPMENT OF THE RFP AND BIDDING PROCESS AS WELL AS FINAL
